

Mr. Vukelja called the Hearing to order at 11:00 a.m.

Mr. Vukelja asked if there were any announcements.

Ms. Hampton stated the following cases were resolved:

Case 3

CITATION NO. 0160147524 - Goodman, Sarah is cited for Section 316.074(1) or Section 316.075(1)(c), Florida Statutes, - Photo/Camera - Failure to Stop at Steady Red Signal

Case 8

CITATION NO. 0160148583 - Teipen, Stephanie is cited for Section 316.074(1) or Section 316.075(1)(c), Florida Statutes, - Photo/Camera - Failure to Stop at Steady Red Signal

Ms. Hampton swore in members of City staff.

Mr. Vukelja announced to the audience the procedure of the meeting and how high the fees could potentially be and further they would be given an opportunity to view the video.

Hearing of Cases:

Case 1

CITATION NO. 0160149961 - McMahon, Eric L. is cited for Section 316.074(1) or Section 316.075(1)(c), Florida Statutes, - Photo/Camera - Failure to Stop at Steady Red Signal

Mr. Eric McMahon came forward and was sworn.

Mr. Jackson stated the City would like to show Mr. McMahon the video and give him the opportunity to make a decision regarding how he wanted to proceed.

Mr. McMahon viewed the video and elected to go ahead and plea to the violations.

Ruling

Mr. Vukelja found Mr. McMahon liable for the violation and ordered the fine amount of \$158.00 plus \$50.00 administrative costs payable within 30 days.

Case 2

CITATION NO. 0160148985 - Sanchez, Yandi is cited for Section 316.074(1) or Section 316.075(1)(c), Florida Statutes, - Photo/Camera - Failure to Stop at Steady Red Signal

Respondent was not present.

Mr. Vukelja viewed the video as Mr. Jackson narrated where the Respondent failed to stop for the red light.

Ruling

Mr. Vukelja found Mr. Sanchez liable for the violation and ordered the fine amount of \$158.00 plus \$100.00 administrative costs payable within 30 days.

Case 4

CITATION NO. 0160149250 - Jones, Denese is cited for Section 316.074(1) or Section 316.075(1)(c), Florida Statutes, - Photo/Camera - Failure to Stop at Steady Red Signal

Ms. Denese Jones came forward and was sworn.

Mr. Jackson stated the City would like to show Ms. Jones the video and give her the opportunity to make a decision regarding how she wanted to proceed.

Ms. Jones viewed the video and elected to go ahead and plea to the violations.

Ruling

Mr. Vukelja found Ms. Jones liable the violation and ordered the fine amount of \$158.00 plus \$50.00 administrative costs payable within 30 days.

Case 5

CITATION NO. 0160148191 - Lebeau, Virginia L. is cited for Section 316.074(1) or Section 316.075(1)(c), Florida Statutes, - Photo/Camera - Failure to Stop at Steady Red Signal

Respondent was not present.

Mr. Vukelja viewed the video as Mr. Jackson narrated where the Respondent failed to stop for the red light.

Ruling

Mr. Vukelja found Ms. Lebeau liable for the violation and ordered the fine amount of \$158.00 plus \$100.00 administrative costs payable within 30 days.

Case 6

CITATION NO. 0160147485 - Robinson, Brett is cited for Section 316.074(1) or Section 316.075(1)(c), Florida Statutes, - Photo/Camera - Failure to Stop at Steady Red Signal

Mr. Brett Robinson came forward and was sworn.

Mr. Jackson stated the City would like to show Mr. Robinson the video and give him the opportunity to make a decision regarding how he wanted to proceed.

Mr. Robinson viewed the video and elected to go ahead and plea to the violations.

Ruling

Mr. Vukelja found Mr. Robinson liable for the violation and ordered the fine amount of \$158.00 plus \$50.00 administrative costs payable within 30 days.

Case 7

CITATION NO. 0160147460 - Taylor, Glenda S. is cited for Section 316.074(1) or Section 316.075(1)(c), Florida Statutes, - Photo/Camera - Failure to Stop at Steady Red Signal

Ms. Glenda S. Taylor came forward and was sworn.

Mr. Jackson stated the City would like to show Ms. Taylor the video and give her the opportunity to make a decision regarding how she wanted to proceed.

Ms. Taylor stated she wanted to proceed with the hearing and stated the person driving her car was a visitor who resides out of the country.

Mr. Jackson argued on behalf of the City that the statute provides how to transfer the liability and that Ms. Taylor was liable unless she completed the affidavit transferring liability.

Ruling

Mr. Vukelja found Ms. Taylor liable for the violation and ordered the fine amount of \$158.00 plus \$100.00 administrative costs payable within 30 days.

Case 9

CITATION NO. 0160148433 - Trescott, Jack N. is cited for Section 316.074(1) or Section 316.075(1)(c), Florida Statutes, - Photo/Camera - Failure to Stop at Steady Red Signal

Mr. Trescott came forward and was sworn.

Mr. Jackson stated the City would like to show Mr. Trescott the video and give him the opportunity to make a decision regarding how he wanted to proceed.

Mr. Trescott stated he wanted to go ahead with a hearing and contest the citation as he was waived through the red light by a flagman who was not visible on the video. Mr. Trescott provided argument as to why he was not in violation.

Mr. Jackson presented argument on behalf of the City.

Ruling

Mr. Vukelja found Mr. Trescott not liable for the violations.

Miscellaneous Business

There was no miscellaneous business.
