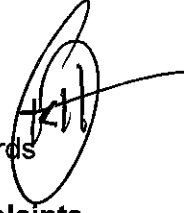

SUBJECT: 2019 Enforcement Profiling / Biased Policing complaints

DATE: January 31, 2020

Per Departmental Standards Directives for Personnel Complaints (1230.15), Biased Policing (500), and Accreditation Standard 2.06M, the yearly statistics for Enforcement Profiling / Biased Policing complaints have been compiled. The Office of Professional Standards received ten (10) complaints relating to Biased Policing in the 2019 calendar year. The complaints raised, related to profiling, racial and sexual discrimination, and harassment during traffic stops, subject stops, and responding to calls for service. The complaints were reviewed by the Office of Professional Standards, six (6) occurred from traffic stops, two (2) occurred from subject stops, and two (2) occurred from calls for service. Of the ten (10) complaints, three (3) traffic citations were issued, five (5) subjects were arrested, and one (1) subject given a Notice to Appear in court. All ten (10) complaints resulted in No Basis for Complaint as no departmental policy violation occurred. Complainants that felt officers had no reason to make contact with them or they were wrongly stopped. All contact made with subjects by officers resulted in adherence to proper traffic stop procedures and sufficient reasons for the contact. During this period, 10,051 traffic citations were issued. Please see attached for field information and demographics for persons contacted (due to data input and reporting, numbers may vary).

In addition, the Office of Professional Standards conducted an annual review of agency practices involving bias profiling which included the areas of forfeitures and seizures. Department policies were recently updated to conform to the Commission for Florida Law Enforcement Accreditation along with I.A.C.P., C.A.L.E.A., and Florida State Statue standards. No deficiencies noted during this review.
