Sec. 102-2, Code of Ordinances – Purpose and Intent – The city commission recognizes that the operation of a Vehicle for Hire (VFH) may significantly impact public safety and an economy that is strongly dependent on tourism. Therefore, it is necessary to regulate VFH services provided to the general public in such a manner as will preserve and enhance the public health, safety and welfare while still allowing VFH operators to be competitive with similar services the city does not have the authority to regulate such as transportation companies.

Sec. 102-38, Code of Ordinances – VFH permit required – Prior to conducting operations in the city, each operator must obtain a VFH permit from city, which must be renewed annually.

I further swear and affirm that each driver of a Vehicle for Hire authorized under this permit meets the requirements for criminal background checks and driving history research reports provided in Section 102-33, City Code. I understand that The City of Daytona Beach is not held responsible or liable for the outcome or results of the criminal history of my employees.
